Dear Mr. Peter Dempsey:

The Destruction Evaluations and Guidance Branch of the National Security Agency completed its evaluation of the *Intimus 175CC6,120CC6 and 60CC6* crosscut shredders against the requirements of NSA/CSS Specification 02-01. These devices will be added to the next release of the Evaluated Products List (EPL) for High Security Crosscut Shredders under the condition that it will not undergo any design modifications that would alter the ability to destroy paper. The capacity of the *Intimus 175CC6* will be listed at 29 reams of paper per hour at 11 sheets per pass, with a 16 inch feed opening. The capacity of the *Intimus 120CC6* will be listed at 17 reams of paper per hour at 6 sheets per pass, with a 12.25 inch feed opening. The capacity of the *Intimus 60CC6* will be listed at 9 reams of paper per hour at 4 sheets per pass, with a 10.25 inch feed opening.

Inclusion of a product in the EPL is not an endorsement by NSA or the U.S. Government. NSA reserves the right to revise, amend, or cancel the EPL as necessary, without prior notice. Any subsequent modifications or design changes that affect the performance of any shredder listed on the EPL shall result in its removal from the EPL unless the changes have been previously coordinated with NSA. Shredders listed on the EPL have only been evaluated for the secure destruction of paper material and have not been evaluated for the destruction of other media such as key tape, floppy disks, optical media, microfiche, microfilm, or other high density magnetic or reduction film material.

Companies are permitted to reference the NSA/CSS Specification 02-01 for High Security Crosscut Paper Shredders and the NSA/CSS Evaluated Products List (EPL) in their advertising provided:

- 1. Such advertising or publicity does not claim or imply U.S. Government or NSA endorsement, approval, certification, or preference.
- 2. Such advertising or publicity does not claim or imply that the company's product is the only one of its type that meets the specification requirements.
- 3. Such advertising or publicity accurately describes the applicable specification, the shredder tests, and the results of the evaluation.

4. The advertised product has been evaluated by NSA (or its designee) and has been determined to meet all of the specification requirements.

Upon receipt of this notification, you may use the following suggested language in product advertising or publicity: *Intimus 175CC6, 120CC6 and 60CC6* high security crosscut shredders have been evaluated by NSA and meet the requirements of NSA/CSS Specification 02-01 for High Security Crosscut Paper Shredders.
